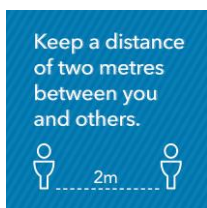


# TRADING STANDARDS AND ENVIRONMENTAL HEALTH COVID-19 BUSINESS GUIDANCE AND INFORMATION

MAY 2020

As the coronavirus (COVID-19) situation evolves, for many of you it may be creating some uncertainty. We understand that it is having a massive impact on businesses across the UK, and hope that you find the following information useful.

## Coronavirus (COVID-19) RULES ON GOING TO WORK



Trading Standards and Environmental Health Officers are authorised to carry out duties under The Health Protection (Coronavirus) (Restrictions) (Scotland) Regulations 2020. The Scottish Government have amended the regulations and published new guidance in respect of this. One of several changes to the legislation is that social distancing measures to slow the spread of coronavirus (COVID-19) now apply to **all** businesses and services.

As a result, our service is receiving an increasing amount of calls about businesses who can continue to operate, and enquiries from those who are considering re-opening.

During these difficult and challenging times, the advice to businesses in Scotland about re-opening has NOT yet changed, as the situation changes, the legislation and list of business which should remain closed will be updated in the link below. If you are on this list, YOU MUST remain closed until the guidance states otherwise.

If you are not on this list, or are unsure if you are legally allowed to re-open, then we would urge businesses to read the [Scottish Government business and physical distancing guidance](#) and in particular their statement on essential services. If you are still unclear whether you should open please contact Trading Standards and Environmental Health for further advice and to establish that appropriate social distancing measures are in place to ensure everyone's safety.

Scottish Government guidance stipulates:

***“Work carried out in people’s homes, for example by tradespeople carrying out repairs and maintenance, can continue, provided that the tradesperson is well and is not showing coronavirus symptoms and neither they nor any of their household are self-isolating. Again, it will be important to ensure that NHS Inform guidelines, including maintaining a 2 metre distance from any household occupants, are followed to ensure everyone’s safety”.***



***All individuals and businesses that are not being specifically required to close should consider a key set of questions– and at all times work on the precautionary basis:***

- ✓ ***is what you do essential or material to the effort against the virus or to the wellbeing of society?***
- ✓ ***if so, can your staff work from home?***
- ✓ ***if not, can you practise safe social distancing and comply with ALL other standard health and safety requirements?***
